THIS AMENDMENT TO SUPPLEMENTAL AGREEMENT NO. 9 to <u>Agreement for Planning</u>, <u>Design and Engineering Services</u>, effective as of the latest date of the signatories indicated at the conclusion of this document (the "Effective Date"), is made pursuant to the terms and conditions of said Agreement by and between **Williamson County**, **Texas** a political subdivision of the State of Texas ("County") and A/E.

RECITALS

WHEREAS, County and A/E previously executed Agreement for Landscape Architectural Services being dated effective 06/27/2015("Phase I Agreement");

WHEREAS, County and A/E previously executed Agreement for Landscape Architectural Phase II Services being dated effective 08/30/2016 ("Phase II Agreement");

WHEREAS, County and A/E thereafter executed Supplemental Agreement No. 9 to Agreement for Landscape Architectural Phase II Services being dated effective 01/10/2023 to provide for Additional Services ("Supplemental Agreement No. 9");

WHEREAS, it has become necessary to supplement, modify and amend the Supplemental Agreement No. 9 in accordance with the provisions thereof.

NOW, THEREFORE, premises considered, County and A/E agree that Supplemental Agreement No. 9 is modified and amended as follows:

ARTICLE 3 TIME FOR PERFORMANCE OF ADDITIONAL SERVICES

Attachment C – Production Schedule of Supplemental Agreement No. 9 shall be supplanted and replaced by Attachment 1 – Production Schedule, which is attached hereto and incorporated herein for all purposes.

ARTICLE 4 TERMS OF AGREEMENT & EXTENT OF AMENDMENT

All other terms of Supplemental Agreement No. 9 and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

NO OFFICIAL, EMPLOYEE, AGENT, OR REPRESENTATIVE OF THE COUNTY HAS ANY AUTHORITY, EITHER EXPRESS OR IMPLIED, TO AMEND, TERMINATE OR MODIFY THIS AGREEMENT, EXCEPT PURSUANT TO SUCH EXPRESS AUTHORITY AS MAY BE GRANTED BY THE WILLIAMSON COUNTY COMMISSIONERS COURT.
