

CONTRACT AMENDMENT NO. 2
TO
WILLIAMSON COUNTY CONTRACT FOR
ENGINEERING SERVICES

This Contract Amendment No. 2 to Williamson County Contract for Engineering Services (“Amendment No. 2 ”) is by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and HDR Engineering, Inc. (the “Engineer”).

RECITALS

WHEREAS, the County and the Engineer previously executed that certain Contract for Engineering Services (the “Contract”), being dated effective March 18, 2021 , wherein Engineer agreed to perform certain professional engineering services in connection with the RM 620/SH 45 intersection to McNeil Road Extension (“Project”);

WHEREAS, it has become necessary to supplement, modify and amend the Contract in accordance with the provisions thereof.

AGREEMENT

NOW, THEREFORE, premises considered, the County and the Engineer agree that the Contract is supplemented, amended and modified as follows:

I. Amendment to Exhibit D - Rate Schedule

II. Terms of Contract Control and Extent of Amendment No. 2

All other terms of the Contract and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.
